#### RESOLUTION #2023-02

A RESOLUTION REPEALING RESOLUTION #2020-06 PERTAINING TO CHARGING OF CERTAIN FEES ASSOCIATED WITH THE INSPECTION AND ENFORCEMENT OF ADOPTED FIRE CODES: PROVIDING FOR THE ADOPTION AND ADMINISTRATION OF A SCHEDULE OF USER CHARGES AS AUTHORIZED BY §191.009(3) F.S.; AND PROVIDING FOR CONFLICTS OF LAW SEVERABILITY, SCRIVENER'S ERRORS AND AN EFFECTIVE DATE.

WHEREAS, the South Trail Fire Protection and Rescue Service District ("District"), is an independent special control district authorized under chapter 2000-484 Laws of Florida, as amended; and

WHEREAS, Florida Statutes Chapter 553, Building Construction Standards, §553.79(2) provides that "an enforcing agency may not issue any permit for construction, erection, alteration, modification, repair, or demolition of any building until the appropriate firesafety inspector certified pursuant to §633.216 has reviewed the plans and specifications required by the Florida Building Code, or local amendment thereto, for such proposal and found that the plans comply with the Florida Fire Prevention Code and the Life Safety Code"; and

WHEREAS, Florida Statutes Chapter 633, Fire Prevention and Control, §633.216(1) provides that "Each county, municipality, and special district that has firesafety enforcement responsibilities shall employ or contract with a firesafety inspector. Except as provided in s. 633.312(2), (3), and (4) the firesafety inspector must conduct all firesafety inspections that are required by law. The governing body of a county, municipality, or special district that has firesafety enforcement responsibilities may provide a schedule of fees to pay only the costs of inspections conducted pursuant to this subsection and related administrative expenses."; and

WHEREAS, Florida Statutes Chapter 191, the Independent Special Fire Control Districts Act, §191.009(3)(d) authorizes governing boards of duly elected fire commissioners to "... provide a reasonable schedule of charges for inspecting structures, plans and equipment to determine compliance with firesafety codes and standards"; and

WHEREAS, it is necessary for the District to establish fees for plan review, inspection, permit issuance and enforcement; and

WHEREAS, it is the intent and purpose of this District Board of Fire Commissioners to maintain a reasonable standard of user charges for new construction permitting and inspection services rendered; and

WHEREAS, the current schedule of user charges relative to construction plan review, permitting, inspection and enforcement services for fire and life safety was modified substantially in 2016; and

WHEREAS, it is necessary to adjust the current schedule of user charges for such services to compensate the District at least in part for the rendering of said services;

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF FIRE COMMISSIONERS OF THE SOUTH TRAIL FIRE PROTECTION AND RESCUE SERVICE DISTRICT THAT:

#### SECTION ONE: EFFECTIVE DATE

Resolution #2020-06 shall be hereby repealed in its entirety effective September 30, 2023 and Resolution #2023-02 shall be effective on October 1, 2023.

#### **SECTION TWO: SCHEDULE OF FEES**

The Board of Commissioners hereby declares that the Schedule of Fees set forth, attached hereto and incorporated by reference herein as Exhibit A are fair and reasonable fees to be imposed upon to those who receive the benefits of the services, reviews and inspections required pursuant to the aforementioned Florida Statutes and described in this Resolution and Exhibit A and hereby imposes said fees. Where a process is not covered by a description set forth in this Resolution or in the Schedule of Fees, the Fire Chief or designee may impose a fee that is the same as the most similar process or if there is no similar process, a fee based upon the actual cost of the service rendered by the Fire District.

SECTION THREE: CONFLICTS OF LAW

Whenever the provisions of this resolution are in conflict with the requirements or

provision of any other lawfully adopted statute, ordinance or resolution, the most restrictive

requirements will apply.

**SECTION FOUR: SEVERABILITY** 

It is the Board of Commissioner's intent that if any section, subsection, clause, or

provision of this resolution is held invalid or unconstitutional by a court of competent

jurisdiction, such portion will be deemed a separate provision and will not affect the

remaining provisions of this resolution. The Board of Commissioners further declare its intent

that this resolution would have been adopted if such unconstitutional provision was not

included.

SECTION FIVE: SCRIVENER'S ERRORS

The Board of Commissioners intends that all sections of this resolution containing

typographical errors that do not affect the intent can be administratively corrected with the

authorization of the District's Chief, or designee, without the need to have the resolution

brought back before the Board.

#### VI. Convenience Fee

A. An amount equal to that charged to the District by the credit card company.

#### VII. Cost Recovery and Collection

- A. All fees for service are due at the time of service; plan review comments, inspection results, or permit sign offs will not occur until all fees are fully paid.
- B. Late Payment Fees: Fees not paid within the terms identified are subject to a one percent (1%) monthly finance charge after thirty (30) days.
- C. Returned Check Fee: Fees associated with returned checks shall be in compliance with Florida Statue 68.065 which are as follows:

Check Value	Fee
\$50.00 or Less	\$25.00 plus bank fees incurred
\$50.01 to \$300.00	\$30.00 plus bank fees incurred
\$300.01 or More	\$40.00 or five percent (5%) of the face value, whichever is greater

- D. Direct costs of collection fees and legal fees associated with collecting Fire District fees shall be added to the original invoice amount.
- E. Submitting parties with outstanding fees shall be required to pay all outstanding fees, in addition to any new project submittal, prior to receiving service.

#### VIII. Fees for Response to Malfunctioning or Nuisance Alarms, Detection, and Suppression Systems

- A. Fire responses to malfunctioning systems not only create a burden on Fire District resources, but also create a safety risk for the general public. Occupants in structures where malfunctioning systems are considered "routine" may become acclimated to the malfunctioning system and not pay attention to these critical systems during an actual emergency. It shall be the responsibility of the owner, agent, and/or occupants of a structure having fire and life safety systems to maintain the systems for the life of the building, by employing a qualified contractor. All structures and premises shall adhere to the inspection, testing, and maintenance requirements, as defined in the most recently adopted versions of the Florida Fire Prevention Code, National Fire Protection Association (NFPA) Standard 25, Standard for the Inspection, Testing, and Maintenance of Water Based Fire Protection Systems, and NFPA Standard 72, National Fire Alarm and Signaling Code.
- B. It is the responsibility of the owner, agent, and/or occupant(s) to have a qualified contractor on site within four (4) hours of the Fire District's request.

- C. If there is no responsible party on-site at the time of a malfunctioning life safety system, in the interest of saving lives and property, the Fire Department may post a "Fire Watch" and fees shall be assessed in compliance with this document. (See Section II (O))
  - 1. First Response: No charge will be incurred if corrective action is taken within twenty-four (24) hours by the property owner or agent.
  - 2. Should no corrective action be taken, and the Fire District is called back for the same alarm within a forty-eight (48) hour period, there shall be a base charge of \$75.00 per occurrence. In addition, the following response fees will apply:

Second Response – 12 Month Period	\$75.00
Third Response – 12 Month Period	\$225.00
Fourth Response – 12 Month Period	\$300.00
Fifth Response – 12 Month Period	\$375.00
Sixth and Subsequent Responses – 12 Month Period	\$450.00 with a mandatory Fire Watch, system requirement for acceptance testing, and inspection fees shall be assessed in compliance with Section II(D) - New Fire Alarm

- IX. Submittal of Inspection, Testing, and Maintenance Reports by Contractors
  - A. The Fire District shall utilize a third-party vendor to collect contractor Inspection, Testing, and Maintenance (ITM) reports. All contractors performing ITM shall submit their reports electronically to the third-party. It is the responsibility of the owner, agent, and/or occupant to ensure that contractors submit their inspection findings electronically. Costs associated with reports submitted to the third-party company shall be the responsibility of the contractor.
  - B. All contractors shall be responsible for immediately notifying the Fire Department when a Life Safety system is taken off line or out of service. Contractors that fail to notify the Fire Department of an out of service life safety system shall be fined a \$150.00 fee for each occurrence.
  - C. Owners, agents, and/or occupants shall be assessed a fee for contractors who fail to submit inspection, testing, and maintenance reports electronically per the following:

First Occurrence	\$95.00
Second Occurrence	\$188.00
Third and all Subsequent Occurrences	\$285.00

#### XIII. Recovery Fees

Recovery Fees include costs associated with hazardous material, suspicious or incendiary fires, investigations, violations of law, and weapons of mass destruction incidents.

A. Cost recovery includes necessary and reasonable costs incurred by the District or its agents in connection with fire suppression, rescue, emergency medical services, mitigation, health, life and safety issues, and investigations of suspicious or incendiary fires, and mitigating, minimizing, or abating hazardous materials or weapons of mass destruction. Cost recovery can include, but is not limited to, the following: actual personnel costs to the District or its authorized agents, costs of equipment, necessary rental or subcontracting, and/or the purchase and costs of expendable and consumable items.

- B. The South Trail Fire District Board of Fire Commissioners (BOFC) fully authorizes the Fire Chief to take all steps necessary to respond and abate emergencies and recover all associated costs as outlined in section XV(A). This includes the adoption of administrative policies regarding the collection of fees, assessments, and liens for services defined in section XV(A). Costs shall be based on the applicable schedule of rates provided by the appropriate Federal Emergency Management Agency (FEMA) table, the Florida Fire Chiefs Association cost recovery schedules, and actual costs for consumables, equipment, response of additional personnel, subcontractors, and other governmental unit employees requested by the Fire District.
- C. Any person(s), property owner, renter or agent who is at fault for the services, including those driving under the influences of drugs or alcohol, or otherwise responsible for the Fire District response and abatement of the incidents in section XV(A) shall reimburse the District in accordance with section XV(B).
  - 1. Reimbursement for expenses is due upon receipt of invoice from the District. Failure to pay the cost recovery invoice within thirty (30) days may result in late fees, and a property lien being placed by the District.
- D. Actions and response as defined in section XV(A) that are caused by a juvenile shall be the responsibility of the legal guardian. The Fire Chief may waive such fees upon enrollment in an approved juvenile fire setters or counseling program.
